# **Session Opens**

The 2024 session of the Rhode Island General Assembly starts today. The House and Senate begin their weekly meetings this week and are expected to conclude the session in June. The next two months will consist of new legislation being filed and the commencement of committee hearings. ### 2023 Highlights

The RIFTHP mailed a summary of the 2023 legislative session to all members in the Fall. The special edition of the Smith Hill Report can be viewed here (click here). The newsletter highlighted some

important legislative accomplishments last session such as the creation of the Hope Scholarship Program at Rhode Island College, the protection afforded paraprofessional school employees assaulted on the job, and funding for the Rhode Island Vision Education and Services (RIVESP) program.

The newsletter also highlighted a few major disappointments, such as the Assembly's failure to improve pension benefits for public employees and its inability to provide medical insurance benefits for adjunct faculty at public higher education institutions.

#### **Senator Bissaillon Sworn-in**

After the death of Senator Maryellen Goodwin, a special election was held to fill the remaining term for Senate District 1. Jacob (Jake) Bissaillon, who had worked as Chief of Staff for Senate President Ruggerio, won the Democratic Primary and then went on to win the General Election with 83% of the vote. He was sworn into office on December 8, 2023. He resigned from his Senate staff position and is now serving in the General Assembly. Senator Bissaillon had the support of the RIFTHP, the Providence Techers Union, and the AFL-CIO.

Said President Flynn, "We congratulate Jake for his impressive win for Senate in District One, Providence. We look forward to working with him on the many issues important to our members and their constituents. I am confident that he will be a strong partner based on our experiences working with him in his role as chief of staff."

#### **Pension Advisory Working Group Formed**

Last session, the General Assembly failed to enact any meaningful pension improvement legislation for public employees. Instead, the Assembly directed the General Treasurer to convene a working group to analyze the impact of the 2021 pension cuts. The exact wording of this provision, included in the state budget, is as follows:

## 36-10.2-11. Advisory working group - Report

a. The general treasurer shall establish and convene an advisory working group to assist

in the review and analysis of the impacts of the Rhode Island Retirement Security Act of 2011 on the state's public retirement systems and their current and retired members. The working group shall develop options for consideration by the general assembly that may be needed to improve the pension programs or address any unintended consequences of the Act. Options, to the extent possible, shall include a clear cost-benefit analysis.

b. The advisory working group may include, but not be limited to, designees from the

following: the office of the general treasurer, actuarial professionals, public sector unions, state and/or national organizations interested in pension reform and sustainability, pension advocacy groups, and financial and investment professionals.

c. On or before March 1, 2024, the general treasurer shall forward a report containing the findings, recommendations and proposed options for consideration to the governor, speaker of the house, and president of the senate.

The pension work group met three times in 2023, with additional meetings scheduled for January 17, 2024, January 31, 2024 and February 21, 2024.

### **RIFTHP Testifies on Pension Improvements**

The second meeting of the Pension Advisory Working Group consisted of presentations made by union leaders representing public employees. RIFTHP President Frank Flynn and Coventry Teacher Alliance President Kelly Erinakes provided testimony at the hearing.

RIFTHP President Flynn urges the Commission to consider several specific pension improvements, such as:

- Increase the accrual rate for each year of service worked by teachers and state workers from the current 1% per year to a higher accrual rate based on years of service with the employer
- Reduction of the penalty imposed on those retiring before their normal retirement age
- Calculate retirement benefits based on the three highest years of salary instead of the five highest years of salary
- Require all newly-hired teachers to participate in social security
- Improve the pension cost of living adjustment (COLA) benefit for current and future retirees

Kelly Erinakes testified after Frank Flynn. She described her personal situation as one of many stories that demonstrate the impact the 2011 law had on teachers. She had 19 years of service at the time the law passed. She had planned a 30-year teaching career, after which she would have received a pension based on 66% of her salary. Because of the law change, she cannot retire after 30 years, she must work 38 years, and her pension will be a dramatically reduced 43% of salary. She further testified that she is not allowed to participate in social security, further diminishing her retirement security.
